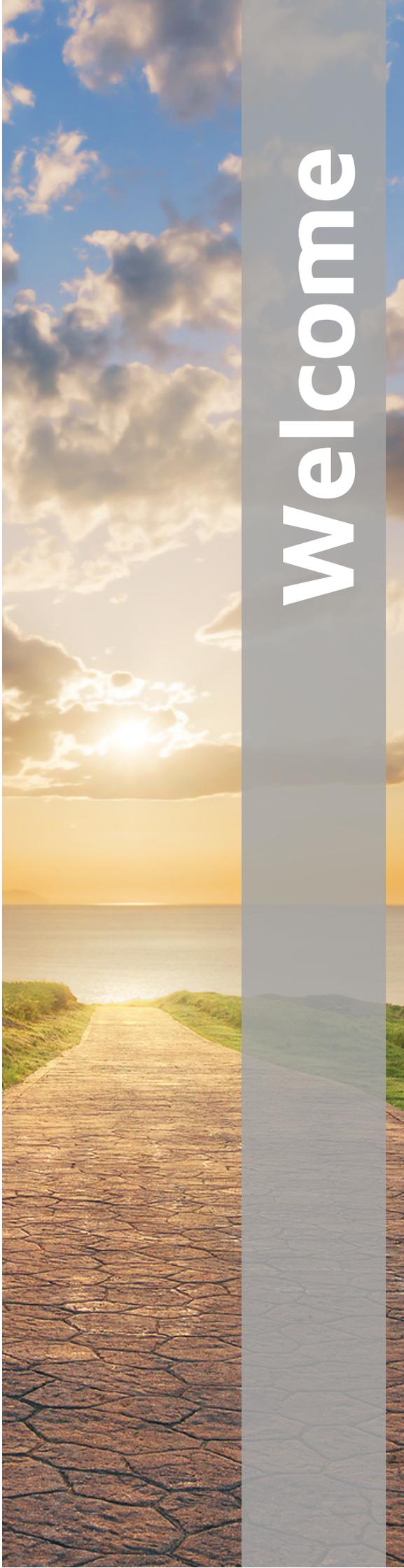

32. What skills do you believe you need to master to attain the success you desire?

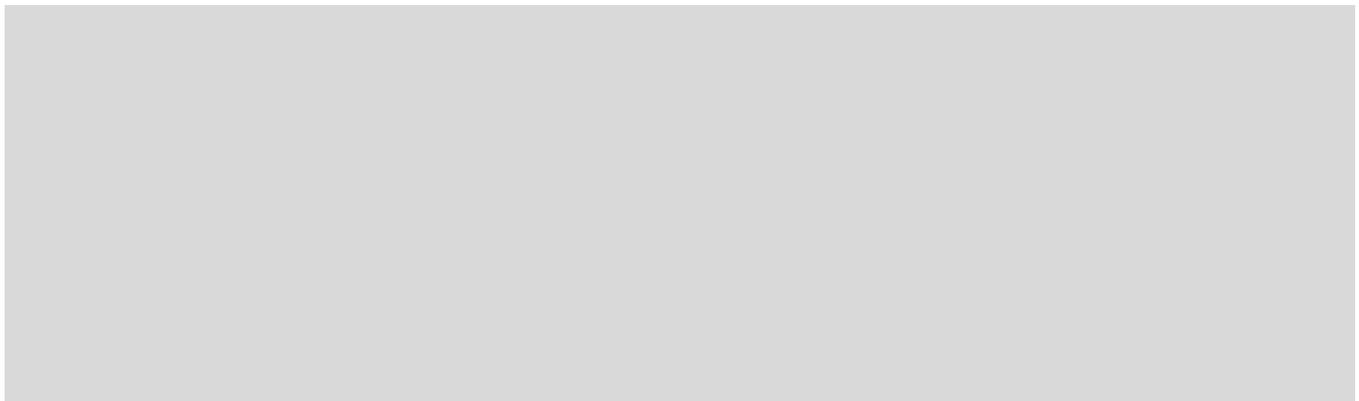

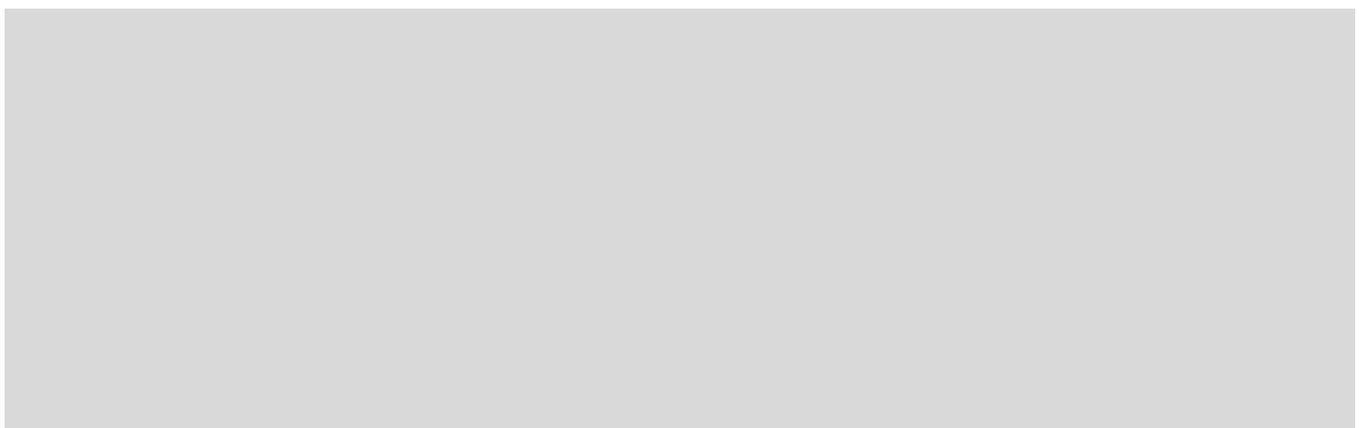
